Nelton Court Opens

Housing Authority of the City of Hartford's Renovated Nelton Court Opens With a Ribbon Cutting

Residents have started moving into new Nelton Court housing in the North End of Hartford. Housing Authority of the City of Hartford (HACH) Executive Director Annette Sanderson and Chair of the Board of Commissioners Marilyn E. Rossetti joined U.S. Department of Housing and Urban Development Field Office Director Suzanne C. Piacentini for a ribbon cutting ceremony last October to open the new low-income public housing development.



Before the complete renovation, the antiquated barracks-style Nelton Court housing built in 1942 had a deteriorating infrastructure that failed to meet modern state and federal standards. Existing buildings were demolished and the new development is comprised of buildings with a density ratio more in harmony with the surrounding neighborhood. Now, Nelton Court offers duplex-style and walk-up affordable housing with eighty new one-, two-, three-, and four-bedroom units.



"We are excited to open the new Nelton Court. This new housing development will positively affect the lives of 80 families living in Hartford," said HACH Executive Director Annette Sanderson. "Working with the residents of Hartford and our other partners, HACH is gradually transforming public housing in the City of Hartford. We are grateful to the U.S. Department of Housing and Urban Development for their help in making this change a reality.

The new low-income public housing is equipped with Energy Star qualified products, includes gas and heat, and features front and back yards. Many Nelton Court units have private entrances, front and back porches, and wide energy-efficient windows with insect screens. Ten of the units are specially outfitted for handicapped accessibility. In addition, the site is equipped with improved parking, sidewalks, open space recreation areas, and two community gardens for residents.

"We are pleased to support the transformation of this housing project for families living in Hartford," said U.S. Department of Housing and Urban Development Field Officer Director Suzanne C. Piacentini. "Modern housing projects such as Nelton Court are an important part of making sure every family has the resources they need to thrive."

The event also featured the dedication of "Alan E. Green Way," in memory of the former executive director of the Housing Authority of the City of Hartford. "Alan Green was committed to affordable housing and improving life in Hartford," said Marilyn E. Rossetti. "We think he would have been pleased to see the completed Nelton Court and we're delighted to honor Mr. Green and his lasting contributions with this street dedication in his native city."

When is my rent due?

Rent is due on the 1st of every month.

How do I pay my rent?

You have several options for paying rent:

- **Mail.** Send in your payment by mail to:

- **Drop Box.** Put your payment in the drop box located outside the main office located at
180 John D. Wardlaw Way.
- **Collection Window.** Bring your payment to the Rent Collection window on Monday 8:30-1:30, Tuesday 12:00-4:30 or Friday 8:30-1:30.
- **Automatic Payment.** Apply for automatic rent withdrawal.

Housing Choice Voucher Wait Lists and Handbooks

The Housing Authority of the City of Hartford is currently administering 1,810 housing choice vouchers, serving more than 4,500 Hartford residents through the Housing Choice Voucher (HCV) program.

The demand for housing choice vouchers often exceeds the resources available and waiting lists are common. In June of 2015, the Housing Authority of the City of Hartford received 20,842 applications requesting to be placed on the HCV Wait List. After a random lottery and preliminary review of the applications, 715 applicants were placed on Hartford's HCV wait list.

Hartford's HCV wait list is closed and applications to the program are not being accepted at this time. Anyone interested in applying for a housing choice voucher can obtain information from any Public Housing Authority in the State of Connecticut with open Wait Lists by visiting the website www.cthcvp.org.

Property owners who are interested in participating in the voucher program can request a Landlord Handbook. The Handbook contains information on the responsibilities of landlords who provide housing to HCV participants. New Bowles Park Tenant Association Webpage and Computer Access; Relocation Interviews Begin

New computer and office supplies will arrive shortly. The Housing Authority provided funding for the Chester Bowles Association to open their office for residents to use the computer on occasion. Once the new redevelopment project starts, residents will be able to fill out applications and apply for jobs as they are posted.

The Housing Education Resource Center will conduct door-to-door interviews at Chester E. Bowles Park to assess each family's temporary relocation needs. It is important that each household participate in the interview process to make their family's move as seamless as possible. To begin the interview process, each head of household must provide their contact information: name, address, home telephone number, cell phone number, and email address to the Housing Authority of the City of Hartford office.
